CONSERVATION AND HUNTING REPORT

FEBRUARY 1, 2023

Upcoming changes for anglers in 2023:

License fees for resident anglers \$23.10

Seniors no longer have to obtain license, but must show proof of age

Walleye limit reduced to 4 for all license holders (i.e. no more conservation limit which was half of daily limit

Pike season will be all year long with a limit of 4 as well as a size limit

Perch limit is 25

NOTE: by 2027 there will be no live bait allowed in any waters in Manitoba (currently there are restrictions where minnows and be used. However, night crawlers and frogs will still be allowed but must be disposed of when you leave the water

Upcoming changes for hunters in 2023:

Big Game draw applications will be accepted from May 1-31 with the draw held on June 21

Did vou know?

In 2022, the Turn in Poachers line had over 5,000 calls to report violations
In the Winter Edition of Outdoor Canada, it was reported that in 2022, Manitoba the total number of NRO's was reduced to 70. A full complement would be in the range of 126 positions.

NRO's are asked to assist with forest fires, protect campers in our parks, monitor commercial and sport fishers, monitor timber harvesting, deal with problem wildlife, patrol backcountry for night lighters, protect our natural resources, as well as enforce traffic violations

Our NRO's are the lowest paid in Western Canada at this point in time
